Dear Father,

St. Paul, in his letter to the Ephesians, tells the Gentile people that what once separated them from the salvation promised to the Jews has been overcome in Christ who has "broken down the dividing wall ... and reconciled both ... through the cross." We believe and proclaim that Christ's gift to us of God's Spirit gives us a new lease on life and empowers us to live in peace.

Unfortunately, this new lease on life and peace is not always apparent to Christians in the Holy Land. Political and economic instability, poverty, and discrimination make it difficult to live in the lands where Christ once walked. The continuing hope and prayer of our brothers and sisters is for peace and a sense of security.

This year, as for the last 50 years, the Holy See urges all parishes around the world to support their brothers and sisters during these difficult times. The Good Friday collection is the major source of income for their Church, and it permits many social, educational, and parish renewal projects, and a measure of peace, for Christians who more than ever depend on our generous support.

So that your parishioners may be aware of the collection taken to help Christians in the Holy Land, I humbly ask you to display the poster included in this package and to announce the collection in online and printed bulletins, and by word of mouth, on the two Sundays before Good Friday.

On behalf of the Custody of the Holy Land, I thank you in advance for promoting the Good Friday Collection and submitting it to your diocesan offices.
